Effluent application shall not occur during rainfall, when heavy rainfall is predicted, or immediately thereafter.</p> <p>Spray head orientation shall be such to minimize aerosol drift and stripping of volatile compounds.</p> <p>Stormwater runoff and all wastewater associated with the facility shall be managed in a manner to prevent a discharge to State waters.</p> <p>The lagoon and surrounding area shall be well maintained and free of trash and other debris. The permittee shall give notice to the Permit Board as soon as possible of any planned physical alterations or additions, including but not limited to, a change of operation to the permitted facility. Notice is required in the circumstances that follow:

- (1) The alteration or addition to a permitted facility may meet one of the criteria for determining whether the facility is a new source in 40 CFR 122.29(b); or
- (2) The alteration or addition could significantly change the nature or increase the quantity of pollutants discharged. This notification applies to pollutants which are not subject to either effluent limitations in the permit or notification requirements under 40 CFR 122.42(a)(1).

Proper operation and maintenance includes adequate laboratory controls and appropriate quality assurance procedures.
