Amendments to the Storm Water Pollution Prevention Plan (SWPPP) are required to be attached if the plan is not current or is ineffective in controlling storm water pollutants.

If the facility is out of business or no longer a regulated facility, please request termination of coverage by completing the Request for Termination (RFT) Form found in the Industrial Stormwater Forms Package. Facilities that continue to discharge wastewater without applicable permit coverage are in violation of state law.

Do not submit this form if submitting a "Request for Termination" (RFT).

Do not submit this form if submitting a "No Exposure Certification."

Pursuant to the letter from the Mississippi Department of Environmental Quality (MDEQ) dated December 29, 2020, we understand that the general permit that authorizes the discharge of storm water associated with industrial activity has been reissued. The Industrial Stormwater General Permit for Industrial Activities (MSR00) was reissued on December 10, 2020, and replaces the previously titled Baseline Stormwater General Permit. Cold Mix, Inc., Wren Facility (Cold Mix) is enclosing a completed *Industrial Stormwater General Permit Re-Coverage Form* and requests that an updated Certificate of Permit Coverage be issued.

Please note that we intend to update Cold Mix's Storm Water Pollution Prevention Plan (SWPPP) to reflect the new requirements of the General Permit. Per the instructions provided for re-coverage, we understand that these updates do not need to be submitted to MDEQ as long as the SWPPP is current and effective in controlling storm water pollutants.
