Facilities that continue to discharge wastewater without applicable permit coverage are in violation of state law.

Pursuant to the letter from the Mississippi Department of Environmental Quality (MDEQ) dated December 29, 2020, we understand that the general permit that authorizes the discharge of storm water associated with industrial activity has been reissued. The Industrial Stormwater General Permit for Industrial Activities (MSR00) was reissued on December 10, 2020 and replaces the previously titled Baseline Stormwater General Permit. PACCAR Engine Company (PACCAR) is enclosing a completed *Industrial Stormwater General Permit Re-Coverage Form* and requests that an updated Certificate of Permit Coverage be issued.

Per the instructions provided for re-coverage, we understand that re-submittal of the Storm Water Pollution Prevention Plan (SWPPP) is not required as long as the SWPPP is current and effective in controlling storm water pollutants.
