Mississippi Power (MPC) requests re-coverage of Plant Ratcliffe under the Industrial Stormwater General Permit (ISGP) No. MSR002117 in accordance with your letter of instruction dated December 29, 2020. Please find attached the re-coverage form as well as an updated copy of the Storm Water Pollution Prevention Plan (SWPPP).

An updated SWPPP is being provided to update MDEQ with the most recent copy. The SWPPP has been modified to reflect the changes in the reissued ISGP, and does not include any changes in design, construction, operation, or maintenance of the facility which would increase the discharge of pollutants to waters of the state and require an amendment as detailed in ACT 9:S-1 (4). Additional updates to the SWPPP include:

- The removal of tanks that have been emptied and decommissioned
- Updated information related to the GAMU Sedimentation Pond to reflect that closure has been completed, and renamed pond to "Pond D"
- Updated table 2.3 to remove activities that are no longer performed on site (CO2 production, Anhydrous Ammonia production, Sulfuric Acid production, ash and coal loading/unloading)
