To whom it may concern:

Attached is the Notice of Termination From to cancel our permit MSG110336 for the Mark Twain Redi-Mix batch concrete plant in Olive Branch, DeSoto County, MS. Condition S-1 of ACT 24 of the Permit require permit holders to submit a description of closure activities for the site. The following addresses the three topics in the permit condition.

Mark Twain has stopped production of redi-mix concrete and have removed all redi-mix material handling, process equipment, raw materials, chemicals, wastes and residues from the redi-mix portion of the Olive Branch Marina Commerce Center back in July 2021.

The location for wash water collection was designated and managed by the prime contractor for the Marina Commerce Center construction site. As the wash water pond was not located within the Mark Twain site boundary and was managed by the prime contractor of the construction site, Mark Twain does not have control over the closure or conversion of this pond.

Final stabilization of the entire construction site, including the location in which the Mark twain Redi-mix batch concrete plant was located, will be managed by the prime contractor for the Marina Commerce Center construction site. Per the Notice of Intent for the full Marina Commerce Center construction site (MSR108170) the estimated construction end date was January 1, 2021 with actual date ending on 6/22/21.
