Dear Mr. Williams:

Enclosed is a Certificate of Permit Coverage granted under the reissued Multimedia Hot Mix Asphalt General Permit (HMAGP). The General Permit was reissued on October 24, 2022, with an expiration date of September 30, 2027. There are several significant changes to the General Permit, which may be found in the "HMAGP Significant Changes" document available at <u>www.mdeq.ms.gov/hmagp</u>. This is a summary and does not negate the need for the coverage recipient to carefully read and be familiar with the permit and its conditions.

Testing requirements for the asphalt dryer are outlined in ACT3, Condition L-5(6) of the HMAGP, and testing requirements for the rock or RAP crusher are found in ACT3, Condition L-6(4) and L-6(5), as applicable. Also, ACT3, Condition S-1(6) of the HMAGP requires submittal of Annual Air Reports. To better track the status of each hot mix asphalt facility and related air requirements, ACT2, Conditions S-5 and S-8 of the HMAGP contain requirements to notify MDEQ when the asphalt facility is removed from a site, even though the HMAGP may be maintained and not terminated.

This permit coverage is issued in accordance with the provisions of the Mississippi Air and Water Pollution Control Law (Sections 49-17-1, et seq., Mississippi code of 1972), and the regulations and standards adopted and promulgated thereunder and under the authority granted to the Mississippi Environmental Quality Permit Board pursuant to Section 402(b) of the Federal Water Pollution Control Act. Any appeal of this action must be made within the 30-day period provided for in Section 49-17-29(4)(b) Mississippi code of 1972.
