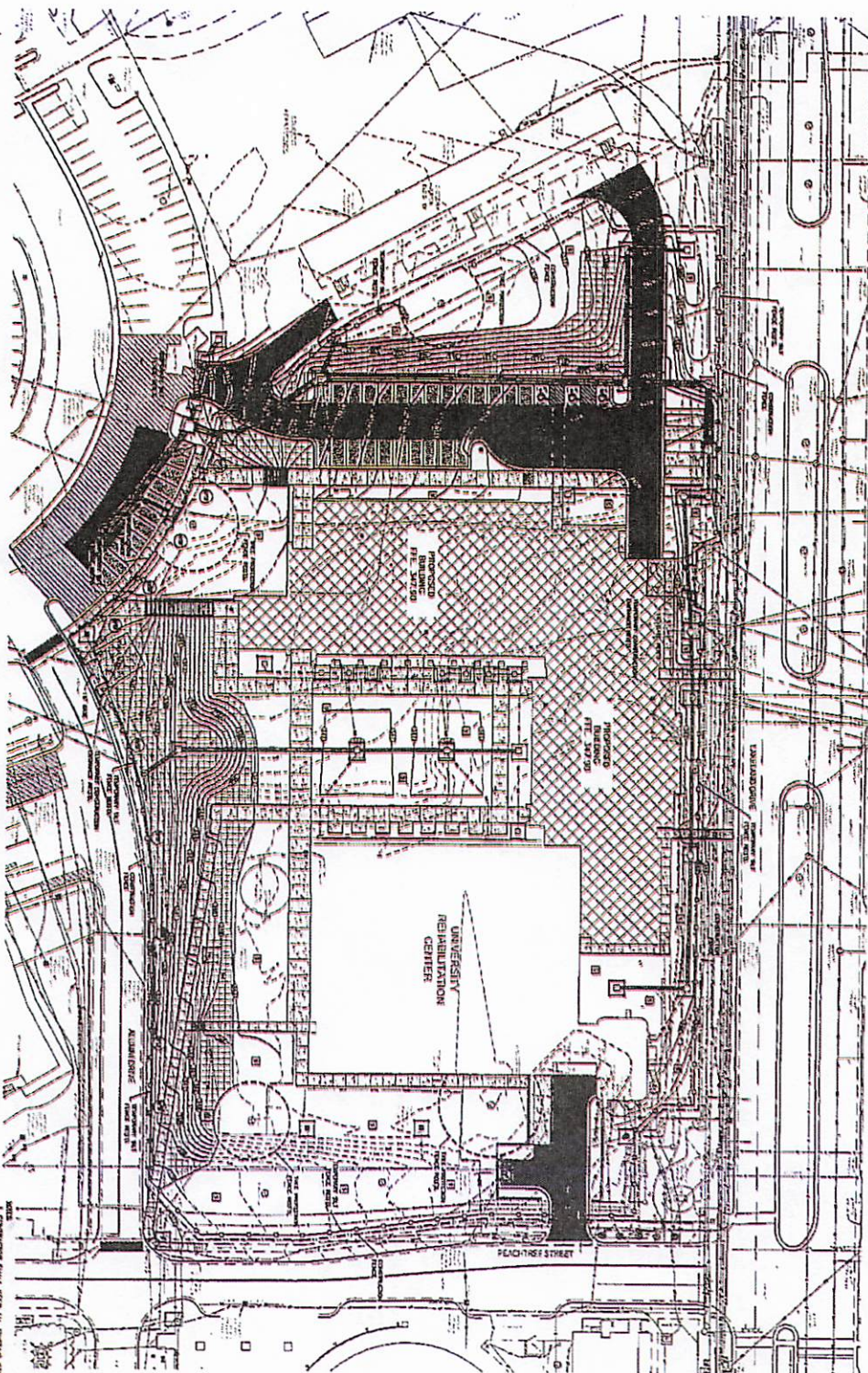
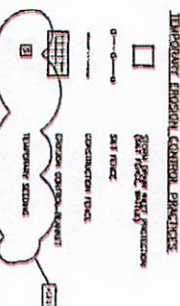
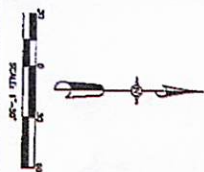

Attached is the map we discussed in our meeting on 11/25/2024, which shows the active area of work within the Asylum Hill Project site (currently still part of Large Construction General Permit #MSR101976). The active area is just under 0.5 acres. The map also shows the recently completed section where grass is just starting to grow. It also shows the stormwater pollution prevention measures in place that we propose to maintain. We will be slowly exposing this area (and backfilling as we go) over the next several months. I anticipate being done with this section in April or May 2025.
