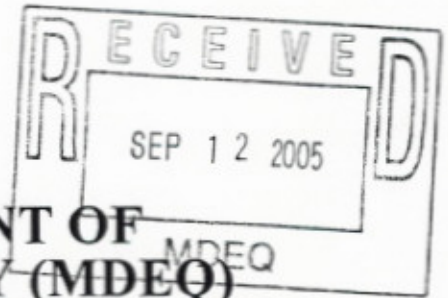

FOR COVERAGE UNDER LARGE CONSTRUCTION STORM WATER  
GENERAL NPDES PERMIT MSR10 3805**

**INSTRUCTIONS**

Applicant must be owner or prime contractor. The owner(s) of the property and the prime contractor associated with regulated construction activity on the property have joint and several responsibility for compliance with the Large Construction Storm Water General Permit MSR10.

File at least thirty (30) days prior to the commencement of construction, fifteen (15) days if a Storm Water Pollution Prevention Plan (SWPPP) is already on file. Discharge of storm water from a construction site without written notification of coverage is a violation of state law.

Submittals with this CNOI include:

- A Storm Water Pollution Prevention Plan as described in the Large Construction General Permit Part III
- A USGS quad map or a copy showing site location

Additional submittals may include the following if applicable:

- Appropriate Section 404 documentation from U.S. Army Corps of Engineers
- Appropriate documentation from Health Department and/or MDEQ Office of Pollution Control (OPC) concerning future disposal of sanitary sewage and sewage collection system construction
- Appropriate documentation from MDEQ Office of Land & Water, concerning dam construction and low flow requirements

4. Individual Onsite Wastewater Disposal Systems for Subdivisions Greater than 35 Lots. A determination of the feasibility of installing a central sewage collection and treatment system must be made by MDEQ. A copy of the response from MDEQ concerning the feasibility study must be attached. If a central collection and wastewater system is not feasible, then please attach a copy of the Letter of General Acceptance from the State Department of Health or certification from a registered professional engineer that the platted lots should support individual onsite wastewater disposal systems.


